You must take action on this violation notice within 21 days. Failure to respond will result in non-renewal of your license to drive and registration by Registry of Motor Vehicles. If you take action after the 21 day period, additional fines will be assessed.

You may pay by mail to the Town of Sharon, parking violations, P.O. Box 203, Milford, Ma 01757 or in person at the Sharon Town Hall, 92 South Main Street Sharon Ma. Do not mail cash. Make checks or money orders payable to Town of Sharon. Include the ticket number and your vehicle registration number.

If you wish to challenge the violation, you must request a hearing by contacting the parking clerk. A hearing may be obtained by one of the following within 21 days of the violation by the registered owner:
